



Holding an Economic Conference To Rebuild and Establish the Foundations of the Iraqi Economy

Our Economic Group aims to save the country, alleviate the suffering of our dear dignified citizens, and to promote their awareness. They deserve altruism and sacrifice of all that is in our possession and ability to rid them of the hardships and disappointments currently existing as well as those in the future. Our economic experience qualifies us to make a number of the proposals, which if implemented will bring about success, development and prosperity to Iraq and the Iraqi citizens. These proposals are represented by:

1. We seek to form a committee of the best Iraqi economists from inside Iraq and from abroad and from the rest of the world to arrange a call for a global economic conference, to which we invite the world's best economists from academic, consulting and economic fields, as well as advisers from various international bodies interested in the Iraqi issue in general and the economic situation in particular.

One of the most important tasks of this committee will be to select at least six global figures as consultants: two specialists in monetary policy, two specialists in financial policies, and two specialists in economic policies. They should have extensive experience in their field of specialization and should have played a distinguished role in their countries in times of financial and economic crises. We will cooperate with various international bodies to develop studies on the economic situation in Iraq , prospects for the future, and how to get out of the crisis with the least losses.

The Iraqi Committee will provide them with all requirements from all official and non-official authorities in Iraq.

2. The committee that we intend to constitute will study all the tasks of the international organizations that can help Iraq in its present crisis, and will study the profile of each organization and the fields in which they can serve Iraq in this situation. These organizations will be contacted, personal meetings can be arranged with them, and dialogue can be conducted with them on how to help

Iraq in its crisis. Invitations will be directed to these organizations to attend the conference, which will include, but will not be limited to, the various United Nations organizations practicing activities in economic side, the World Bank and the four organizations associated with it, namely: International Development, International Finance Organization, International Investment Guarantee Agency, and the International Center for Investment Disputes, which can lead Iraq in various economic fields, as well as the International Monetary Fund, the European Organization for Economic Cooperation and Development, the World Trade Organization, the International Finance Institute, the World Chamber of Commerce, World Trade Center, Economic Organization for Cooperation and Development, World Economic Forum, and other international organizations that can provide advice and support to the Iraqi economy and find solutions to the deteriorating situation in Iraq.

- 3. The conference proposed to be held can last for three days, followed by a workshop for a period of at least one week.
- 4. The international investment figures assigned by the expected conference to cover the various aspects of economic policies will develop their proposals based on the conference and the subsequent workshop, and they will submit their unified recommendations, where there is likely to be a conflict due to different disciplines. The unified recommendations shall take into consideration all the factors that can help develop monetary, financial and economic policies that are available and integrated in order to advance the country and protect it from an unknown and dangerous future that awaits it and may fall into it.
- 5. A shall follow-up committee be constituted implement to the recommendations. The stakeholders can be periodically invited for a meeting to follow developments. achievements. obstacles, changes and future expectations. The same conference will be called upon to convene after one year to evaluate the experience, follow-up achievements, and set new recommendations.

- 6. International investment figures shall be selected in coordination with your establishment after being nominated by you.
- 7. With this situation ahead, we need more than an expert, so that each can look at the problem from a certain angle and submit his solutions. The meeting of these figurers can draw up monetary, financial and economic policies that are closest to reality to save the country from what can be expected of an unknown future and from serious effects and suffering of citizens.
- 8. The main objective of the move is to build a free economy that positively deals with the Iraqi surrounding countries as well as with the global economic establishments in the free world, that will be for the sake of the joint benefit from the economic ability of Iraq, which has the second largest reserves of oil and gas in the world, in addition to the large stockpile of uranium and sulfur in Iraq.

Establishment of a media and news institution, that will establish a television channel and economic news websites through all means of social media, to assume the task of developing sound economic plans to establish the Iraqi economy, and to host economic advisers from various disciplines to develop the Iraqi economy, and to benefit from experts from the economically developed countries according to sound economic standards, and to communicate with all international economic organizations.

Construction and Contracting:
